

Hello Everybody,

For those that may not know, Jeanine Pirro is a former Westchester County District Attorney. She was a factor in keeping me in prison. She fought all 7 of my appeals even though I was arguing my innocence based upon the DNA which did not match me, and blocked further DNA Testing which, when performed by her successor not only again affirmed my innocence but also proved the guilt of the real perpetrator. She also played a role in a variety of other injustices in Westchester, in which people were convicted of murder but whose convictions were overturned based upon her office withholding evidence from the defense attorneys, and another person had her conviction overturned based upon a similar thing. There are probably other cases that she was involved in which have not as yet been exposed.

She has recently been given a judge show on Channel 11, entitled *Judge Jeanine Pirro*. Myself, along with about 35 people from Westchester recently held a press conference/boycott/protest outside of Warner Brothers, which is syndicating the show. Our objection to the show is that it depicts her as a crusader of justice with integrity, whereas in reality she engaged in regular prosecutorial misconduct. As I said the day of the protest, I do not want her to have the opportunity to try to reinvent herself; instead I want the world to know exactly how she was. Anybody who is guilty of engaging in regular prosecutorial misconduct, who operates on a win at all costs basis, even at the expense of innocence and injustice, who is willing to engage in the tactic of withholding of evidence as these cases show, should not be rewarded with a judge show. Instead, she should be punished. To do otherwise sends the wrong message.

What if you, your son or daughter was a victim of her in any of the aforementioned cases? I am now asking everybody who is in support of my advocacy work against wrongful convictions, who is against injustice, who is against the withholding of innocence, who finds prosecutorial misconduct to be morally wrong, and is willing to take a stand against it, to join me in calling CW11 and expressing that they find her show to be morally unacceptable, and insist that it be pulled off of the air. Please also make it clear that in the event that they do not pull the show, that you will boycott Channel 11, its affiliates, anybody that has ads on the station. Please mention that future protests will be held again in the future if necessary. If we all speak up in one voice, and be clear that we are not going away, we can get results.
